

RESOLUTION NO. 2015-73

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
SIMI VALLEY ESTABLISHING CITY COUNCIL MEETING
SCHEDULE FOR THE CALENDAR YEAR OF 2016

WHEREAS, the City Council shall set an annual City Council meeting calendar to establish dates and times assisting City Council and staff with advance planning and scheduling of City business; and

WHEREAS, pursuant to Section 2-1.101 of the Simi Valley Municipal Code, the following calendar is established, notwithstanding the scheduling of additional meetings as required upon proper notice under the Brown Act; and

WHEREAS, the City Council pursuant to this Resolution sets aside a time period for closed session before the open session portion of each regular meeting.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SIMI VALLEY DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. The City Council hereby establishes 5:30 p.m. as the regular meeting time for each regular meeting. Only closed sessions may be held between 5:30 p.m. and 6:30 p.m. No closed session of the regular meeting will be held during that time period unless the posted agenda of the regular meeting indicates that such closed session will take place at a particular time in that time period. In the absence of such notification on the agenda, the open session portion of the regular meeting shall commence at 6:30 p.m.

SECTION 3. With proper notice during the year, meetings may be cancelled, rescheduled, or added as necessary pursuant to California law.


SECTION 4. The City Clerk shall certify to the adoption of this resolution and shall cause a certified resolution to be filed in the Office of the City Clerk.
