A JOINT RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SIMI VALLEY AND THE BOARD OF DIRECTORS OF VENTURA COUNTY WATERWORKS DISTRICT NO. 8 AMENDING TERMS AND CONDITIONS OF EMPLOYMENT FOR MANAGEMENT-DESIGNATED EMPLOYEES

WHEREAS, on December 1, 2025, the City Council and the Board of Directors approved Resolution No. 2025-38 and WWD-301, revising the terms and conditions for Management-designated employees; and

WHEREAS, the City Council and the Board of Directors desire to correct a discrepancy with the tuition reimbursement amount for Management-designated employees for Fiscal Years 2025-26 and 2026-27; and

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SIMI VALLEY AND THE BOARD OF DIRECTORS OF VENTURA COUNTY WATERWORKS DISTRICT NO. 8 DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. The tuition reimbursement section in Resolution No. 2025-38 and WWD-301 shall be amended to read as follows:

12. Tuition Reimbursement


Employees may receive reimbursement for tuition expenses as outlined in Policy 24, Training and Tuition Reimbursement, in the Management Employees' Manual to a maximum of \$1,600 per fiscal year.


SECTION 2. The provisions shall be effective as of July 1, 2025, unless otherwise specifically indicated.

SECTION 3. The City Clerk/District Secretary shall certify to the adoption of this resolution and shall cause a certified resolution to be filed in the Office of the City Clerk.
